REFLECTIONS ON A YEAR OF UNCERTAINTY...

The year 2020 began as any other year, with anticipation and excitement. The Foundation's Annual Meeting was held on March 4th as we invited our stakeholders to "Come to the Table". Our story from 2019 unfolded before our eyes as many stood up to share their own story about our community foundation. On the way out the door, one of our nonprofit directors approached me to request a meeting to discuss the coronavirus. I remember getting a tingling sensation and thinking, "there is more to this than what meets the eye!" Two weeks later, the page in our story turned. I sent most of my staff home to work, thinking it would be for a few weeks at most. It turned out to be almost three months.

As we began to adapt to our public health lockdown as an essential business, the Foundation immediately resurrected our Disaster Relief Fund and began strategizing. Amid extra-long food lines, business and school closings, and a shortage on everyday household supplies, we were facing other issues of economic volatility, racial injustices, and political uncertainty. Stress, fear, and exhaustion were taking a toll in our communities. We relied on you—our stakeholders—to generously support our disaster relief efforts. We worked diligently with our partners to provide area nonprofits grants so they would be able to continue their case management and keep their doors open. We also partnered with Columbia and Montour Counties to facilitate the distribution of COVID County Block Grant funds to area small businesses and nonprofits. With the realization that our nonprofits were hurting, we focused on keeping them in the loop, sent words of encouragement, and continued efforts of regular communication.

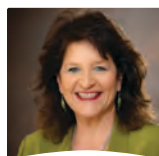
Even in this period of uncertainty, the story of our Foundation continued. Our team reunited in June under social distancing practices as we celebrated being back together at the office. While we were learning a "new normal," we continued to see many positives through our work.

- *During celebrations for the 100-year anniversary giving women the right to vote, our Women's Giving Circle launched its annual membership drive to support local women and girls.*
- *For the first time ever, our Youth in Philanthropy program went virtual as we launched our kickoff sessions in October. Designed to be interactive for the students, we*

delivered a box of supplies and gift certificates for lunch to each school as we celebrated the start of another year. Students and advisors from eleven schools helped us make these virtual sessions a great experience.

- *We continued to work with generous philanthropic partners who created new funds, even in the extreme conditions with which we were working. We are humbled by their trust.*
- *After a year-long journey, we celebrated the launch of our new brand on December 7th. We are now known as the Community Giving Foundation. Every affiliate and foundation program are now connected to us and to each other. We are truly a family and are proud to be identified with one another.*

In quarantine and throughout the year, I couldn't help but think back to the 1970s and all the messaging that included the infamous peace sign. I always believed that its symbolism was to remind us of love, friendship, unity, kindness, and a hope for the future. As we begin 2021 and a new chapter for our Foundation, let us shine a little peace on our neighbors, love to our community, and kindness to all who need it.

DISASTER RELIEF FUND ♥ Foundation Provides Pandemic Relief

Banding together in times of unfortunate and unexpected events is not new for the Community Giving Foundation or its dedicated community members. When the COVID-19 pandemic hit our region, we were prepared to continue partnering with local organizations to promote sustainability and recovery through the Disaster Relief Fund. Positioned as a community leader and trusted resource, the Foundation quickly jumped into action as local organizations began experiencing heightened needs. Using the relationships we had already established with local nonprofits and other community leaders, the Foundation identified ways our nonprofits could use flexible resources to have a greater reach as needs grew around them.

Foundation Holds Disaster Relief Grant Rounds

Two Disaster Relief Fund grant rounds were held—one in April to meet immediate needs in the community and a second over the summer to consider long-term effects of the pandemic for area nonprofits. Grantmaking decisions were managed by a special Disaster Relief Advisory Committee comprised of regional representatives from ten nonprofit and human service organizations and Foundation board members.

Funding from individual donors, Foundation funds, and local businesses helped the Community Giving Foundation award grants to over 75 area nonprofits to meet requests including: essential items (personal care, cleaning supplies, medical supplies, nonperishable foods), meal prep and distribution, equipment maintenance, financial assistance and crisis services, educational programs, and human resource needs. Through these grants, recipients were able to provide continued services to clients at a critical time.

With an established process in place to support disaster relief grantmaking, the Foundation also collaborated with the Columbia County and Montour County Commissioners to administer applications for local nonprofits and small businesses via the COVID-19 County Relief Block Grant.

Through all of these disaster relief efforts, the Community Giving Foundation facilitated the distribution of over \$3.5 million for recovery across our region.

The Foundation is thankful for the countless individuals, families, and organizations that make the Central Susquehanna region a strong and resilient community. We have supported local recovery and achieved a greater impact through your partnership.

DISASTER RELIEF IMPACT STORIES

Many individuals, businesses, and Foundation funds generously supported the Foundation's Disaster Relief Fund in 2020. Two grant rounds were held to meet both immediate needs and long-term effects of the pandemic for area nonprofit organizations and the community members they serve. Below are just a few examples of the impact we have had this year.

Food Security in Central PA

The Central Pennsylvania Food Bank used its grant from the Foundation's Disaster Relief Fund to provide boxes of healthy food (including produce, meat, milk, and shelf-stable items) to 625 families across the region. With economic uncertainty early on in the pandemic, the Food Bank used this much needed support to ensure that no one went hungry during these unprecedented times.

PPE Access to Local Nonprofits

As a medical office, the Dental Health Clinic in Berwick has seen many changes as a result of COVID-19, specifically in the enormous responsibility of making their office a safe place for patient care. With constantly changing safety protocols, the Clinic found themselves in great need of additional protective gear. Through a Foundation grant, the Clinic was able to purchase the necessary personal protective equipment (PPE) to continue treating patients in the community.

Continuing Mental Health Services

Mental health has become a rising concern as the pandemic has continued to sweep the nation. In Northumberland County, the Merakey Foundation serves 350 adults struggling with serious mental illness and addiction. Support from a Foundation grant has allowed Merakey to purchase the equipment needed to provide telehealth services to these community members. Assuring that Merakey consumers can easily access their team of providers prevents recovery relapses from contributing to the mounting collateral damage created by COVID-19.

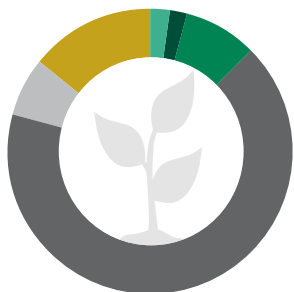

AGAPE: Love From Above To Our Community Agency Fund

Agency Endowment Fund

AGAPE is a non-denominational, faith-based mission that serves the people in Columbia and Montour Counties. Their goal is to “fill the gaps” which currently exist between people in need and the community services available to assist them. Their endowed agency fund provides support for the benefit of AGAPE so long as it is recognized as a 501(c)(3) organization.

Alice Remington Fund

The Alice Remington Fund provides support for health and wellness purposes within the Foundation’s service area. Alice’s spirit and hard work with the Auxiliary demonstrate her commitment to volunteerism in the Berwick community.

Ben Franklin Trust

Unrestricted Fund

In 1789, Benjamin Franklin wrote his last will and testament. In it, Franklin directed that after 200 years, half of the accumulated funds of his estate should go to the State of Pennsylvania to be used for whatever the public officials felt was necessary. The State Legislature split the money among most of the community foundations across the state, to which Community Giving Foundation was included. This Fund supports programs and services that work to increase knowledge and/or quality of life or that inspire positive outcomes for individuals and families living across our regional service area of Columbia, Lower-Luzerne, Montour, Northumberland, Snyder and Union Counties.

Joshua Martz Scholarship Fund

Scholarship Fund

The Joshua Martz Scholarship Fund provides scholarship awards for students declaring a major in special education. The award will alternate between graduating students from Benton High School and Millville High School.

Melba Hyde Scholarship Fund

Scholarship Fund

Benefiting a Benton Area High School graduating senior, the Melba Hyde Scholarship Fund is awarded to a student attending a post-secondary school and demonstrating financial need.

The 12th Man Football Scholarship provides awards for the benefit of a graduating Berwick High School senior who participated in football and is not receiving a full or partial scholarship.

The Bart Rado Senior Memorial Award provides scholarships for the benefit of a graduating Berwick High School senior(s) who participated in football and is not receiving a full or partial athletic or academic scholarship. Special consideration is given to quality players/students.

Berwick Area School District Trust Scholarship Fund

Scholarship Fund

The Berwick Area School District Trust Scholarship Fund provides awards to the top academic senior graduating from Berwick High School.

Class of 1950

Scholarship Fund

The Class of 1950 Fund provides scholarship(s) for the benefit of graduating Berwick High School senior(s) who have shown improvement in attendance, grades, behavior, and discipline during their high school career.

David L. Force Business Ed. Scholarship Fund

The David L. Force Business Education Fund provides scholarship(s) for the benefit of a graduating Berwick High School senior(s) who participated in the business education curriculum with the highest GPA. Student can be entering a 2-4 year post-secondary school.

Dr. Ralph J. and RJ Norce Strive Scholarship

Scholarship Fund

The Dr. Ralph J. and RJ Norce Strive Scholarship Fund provides awards for the benefit of graduating Berwick High School senior(s) with a GPA of 85 or above who plans to attend post-secondary education. Special consideration is given to students with hardship who “sees the light” their senior year.

E. Saracino Football

Scholarship Fund

The E. Saracino Football Fund provides scholarship(s) for the benefit of graduating Berwick High School senior(s) who participated in football.

Frank Souchak Award

Scholarship Fund

The Frank Souchak Award provides scholarship(s) for the benefit of graduating Berwick High School senior(s) who have not received scholarships from other entities; participated to their highest ability in the areas of academics, athletics, vocations and/or music; demonstrated high achievement and was highly involved with school and community.



GRANTMAKING AT THE FOUNDATION

The Community Giving Foundation seeks to increase the quality of life for residents of the Central Susquehanna region through grant investments. Grants are recommended through a variety of different processes based on the type of fund. Overall, grants address community needs, programs, and projects that are making positive impacts.

Grants from **donor advised funds** reflect the charitable goals of individual fund advisors and represent both donor-initiated grants as well as responses to grant applications.

Grants from **field of interest funds** reflect the specific program area for which the fund was created. These grant decisions are sometimes guided by a fund committee.

Grants from **agency funds** and **designated funds** reflect the beneficiary organization(s) named at the fund's establishment.

Each grant application submitted to the Community Giving Foundation is carefully screened and reviewed by a committee specific to that grant cycle. Grant committees are made up of Foundation board members and community volunteers. The Foundation encourages a diverse group to participate on advisory committees, promoting thoughtful discussion for funding decisions.

Field of Interest Fund

The Golf Team Memorial Award provides charitable support for the Berwick Area School District golf team.

Individual Achievement Award

Scholarship Fund

The Individual Achievement Award provides scholarship(s) for the benefit of Life Skills or Special Education students graduating from Berwick High School.

Jacoby Business Department Award

Field of Interest Fund

The Jacoby Business Department Award provides charitable support for the Berwick Area School District business department.

Marie Rudy Music Fund

Field of Interest Fund

The Marie Rudy Music Fund provides scholarship(s) for the benefit of Berwick High School students (grades 9-12) who excels in music and has financial need. The award should be used for the purchase of an instrument, music lessons, or music education. If the student is graduating, the award should assist with post-secondary educational costs for a degree in music or music education.

Russell H. Zimmerman Scholarship Fund given by Doris Keller and Robert Clark Hosler

Scholarship Fund

The Russell H. Zimmerman Scholarship Fund awards a one-year scholarship to a deserving Berwick High School graduating senior who is attending Bloomsburg University in a field of his/her choice.

Ruth Peck Matzko, RN & Michael J. Matzko, MD Scholarship Fund

Scholarship Fund

The Ruth Peck Matzko, RN and Michael J. Matzko, MD Scholarship Fund awards scholarship(s) for the benefit of graduating Berwick High School senior(s) who is pursuing a health-related occupation at a 2- or 4-year post-secondary school. Consideration is given to students with financial need.

Susquehanna Arts and Crafts Scholarship Fund

The Susquehanna Arts and Crafts Fund awards scholarship(s) for the benefit of graduating Berwick High School senior(s) who is a deserving art student continuing their education in the arts field.

Tuzzi Health / Financial Need Scholarship Fund

The Tuzzi Health / Financial Need Fund awards scholarship(s) for the benefit of graduating Berwick High School senior(s) who is pursuing a health-related field at a 2- or 4-year post-secondary school. Consideration is given to students with financial need.

Walter and Florence Vorbleski Scholarship Award

The Walter and Florence Vorbleski Scholarship Fund provides awards for graduating high school seniors and/or non-traditional students taking at least 12 credits per year. Recipients must reside in the Berwick Health and Wellness service area and major in one of the following areas: pre-med, nursing, physician assistant, nurse practitioner, or surgical technician.

Wrestling - Mat Backers Tom Carroll Memorial Scholarship Fund

The Wrestling - Mat Backers Tom Carroll Memorial Fund provides scholarship(s) for the benefit of graduating Berwick High School senior(s) who participated in the Berwick wrestling program.

Berwick Area Swimming Pool Association Agency Fund

The Berwick Area Swimming Pool Association provides the necessary management of the Ber-Vaughn Pool in the community. This endowed fund will benefit the operations of this initiative so long as it is recognized as a 501(c)(3) organization.

Berwick Area United Way Agency Fund

The Berwick Area United Way fights for the health, education and financial stability of every person in the Berwick area, bringing people and organizations

together to invest in our community. Their endowment agency fund provides support for the benefit of the United Way so long as it is recognized as a 501(c)(3) organization.

Berwick Area YMCA Agency Fund

The Berwick Area YMCA serves the needs of members and the community at large through a number of programs focused on strong and healthy living. Their endowed agency fund provides support for the benefit of the YMCA so long as it is recognized as a 501(c)(3) organization.

Berwick Arts Fund ♥ Community Impact Fund

Berwick Arts gathers the community together to spread hope through art in our region. The Berwick Arts Fund supports projects and activities of the Berwick Arts organization including, but not limited to, art projects, installations, murals, sculptures, art education, shows/events, etc. The group invites all community members to participate and build the art culture in the Berwick area.

Berwick Catholic Education Fund

This former fund supported the operational budget of Holy Family Consolidated School in Berwick, PA.

Berwick Dental Clinic Agency Fund

The Berwick Dental Clinic provides dental health services, support and education to residents of Berwick, PA and surrounding communities. Their agency fund provides support for the benefit of the Clinic so long as it is recognized as a 501(c)(3) organization.

Berwick Historical Society Agency Fund

The Berwick Historical Society provides assistance in historical research and preservation of historical assets in the community. Their agency fund provides support for the benefit of the Society so long as it is recognized as a 501(c)(3) organization.

Berwick Mayor's Charities Fund

The Berwick Mayor's Charities Fund was created to provide support for the charitable activities of the Mayor's Office to support the charitable concerns of the Berwick area.

Berwick Test Track Disc Golf Community Impact Fund

This fund provides resources for charitable purposes for the disc golf field and equipment at the Berwick Test Track Park.

Beyond Violence Agency Fund

Beyond Violence provides shelter services, support, counseling and education to women who are victims of domestic violence and their families in the Berwick and surrounding area. This agency fund provides support for the benefit of its mission so long as it is recognized as a 501(c)(3) organization.

Beyond Violence Non-Endowed Agency Fund

This non-endowed agency fund provides charitable support to benefit Beyond Violence's mission in the greater Berwick community.

Bittenbender-Henry Fund

NURSE-FAMILY PARTNERSHIP

Community Giving Foundation and Geisinger Clinic

Beginning in 2001, the Community Giving Foundation partnered with the Geisinger Clinic to bring the Nurse-Family Partnership (NFP) program to our region. NFP is one of 14 blueprint prevention programs in the country, with goals to improve health during pregnancy, promote healthy child development, and promote self-sufficiency. First-time mothers who qualify for WIC or medical assistance can enroll in the program, and are paired with a registered nurse who visits the clients until the baby turns two years old.

Over the last 19 years, nearly 400 mothers have enrolled in NFP throughout the Foundation's service area. In 2019-2020, 27 mothers were active in our region. Last year, the Foundation and Geisinger Clinic received a grant through the NFP National Service Office for an expansion of the program, allowing an additional 100 mothers to participate. With a focus on prevention and self-sufficiency, Nurse-Family Partnership continues to make a difference for a lifetime.

"As a client, I always looked forward to my nurse coming to my house. She was a ray of sunshine and made me feel as if I could do anything. She encouraged me when I doubted myself and was the first person I wanted to talk to when I was scared or had exciting news. Jesse's early childhood was much different, and led him to Girard College, a school for fatherless boys in Philadelphia. SUNBURY HEALTHCARE ORGANIZATIONS

General Healthcare Grants

Started out of the sale of the Sunbury Hospital in 2005, Community Giving Foundation: Sunbury has remained committed to improving healthcare in the local community. Each year, Sunbury supports many local nonprofit organizations dedicated to providing quality care at affordable costs to area residents. These programs became even more important this year, when hospitals were flooded with COVID-19 patients and additional safety protocols were required.

A Community Clinic, Inc. treats patients for a range of health concerns, from acute care to managing chronic illnesses. Through grant support, the Clinic is able to provide quality healthcare to the uninsured by reducing the financial burden on the patients and local physicians/hospitals. In a similar vein, Susquehanna River Valley Dental Health Clinic provides low cost preventative and necessary dental care for local residents who otherwise could not seek treatment.

Specific to COVID-19 response, a grant to sustain health care services through Gaudenzia, Inc. defrayed the costs for face shields, masks, gloves, gowns, and deep cleaning/sanitizing supplies. By maintaining a sufficient supply of PPE, Gaudenzia was able to care for clients who were symptomatic and needed to be isolated. Funds also helped sustain operations by increasing opportunities to remotely connect clients with their families and support systems while in residential rehabilitation.

Celebrating a Movement; Preserving a Legacy

As a group dedicated to the empowerment of women, we can't pass up the chance to remember and celebrate an important achievement in American History. The year 2020 marked the 100th anniversary of the ratification of the 19th Amendment, which constitutionalized women's right to vote. The persistency of a group of fearless women through a grassroots movement led to further reforms that continue today. The Women's Giving Circle remembers the women who fought tirelessly to make their voices heard and opinions valued as we continue to come together and create change in our communities.

WOMEN'S GIVING CIRCLE

The Women's Giving Circle had a busy year as we focused on collaboration, empowerment, and learning to make a difference for local women and girls in our community. February's annual Outreach & Education luncheon welcomed "unexpected perspectives" from three speakers—Samantha Norton, Joanne Troutman, and Bonnie Trump—who encouraged the use of space to lessen anxiety, reminded us that not every battle is worth the fight, and celebrated how the stories of our lives continue with each new chapter. Their perspectives encouraged us all in our own journeys.

Though we weren't able to celebrate together at our annual grant awards dinner, the Women's Giving Circle held its third competitive grant round to support projects and initiatives across the Central Susquehanna region. A total of \$20,000 was awarded to 18 organizations to fund programs that meet physical needs, financial assistance, empowerment and education, career support, and healthy lifestyles for local women and girls. There is an incredible trickle-down effect to our impact—these 18 grants will serve hundreds of women across our region as we continue to achieve a greater impact in our mission together.

Friends of the Women's Giving Circle participated in two new virtual programs this year. The group hosted its first "On the Bright Side" in September as a casual, online lunch break to connect with local women, refuel, and encourage each other under hectic and unusual circumstances. The Women's Giving Circle also sponsored Leadercast Women 2020 in partnership with the Columbia Montour Chamber of Commerce. The event included two virtual sessions featuring six inspiring women who imparted leadership lessons for personal and professional development.

With 70+ members, the Women's Giving Circle provides a bigger impact by pooling donations and working together to enrich the lives of those in our community. This dynamic group of women continue to engage in new relationships, provide valuable grants to local organizations, and share their passions with the community. SHAPE OF JUSTICE

After seeing a need in rural Pennsylvania, Shape of Justice launched its work with a single mission: to provide free menstrual hygiene products to food pantries, shelters, and other organizations serving low-income women and girls. With partnerships across the Central Susquehanna region—including support through grants from the Women's Giving Circle—Shape of Justice now works in 12 rural counties in Pennsylvania and have distributed more than 600,000 tampons, pads, and liners in local communities.

"Personal care items are not covered by SNAP or other charitable sources. I have literally had women get tears in their eyes when I offer them these products. One woman told me she wears three or four pairs of underwear at once and washes them at night since she can't afford to purchase pads or tampons. Being given hygiene products has enabled her to regain a sense of pride in herself."

GOING VIRTUAL

Beginning with the Youth in Philanthropy end-of-year ceremony in Spring 2020, the program transitioned to a virtual format as a result of the COVID-19 pandemic. With concern for the health and safety of students and partners, meetings continue to be held through web-based platforms for the fall and winter months.

The Foundation recognizes that students have been resilient throughout this year's educational adversities. Continuing philanthropy learning during trying times is more important than ever. To keep the virtual meetings interactive and engaging, students received lunch and boxes of supplies and tools to use throughout the meetings.

TEACHING PHILANTHROPY THROUGH ACTIONS

The Youth in Philanthropy program at the Community Giving Foundation provides high school students across the region an opportunity to learn about philanthropy and participate in the grantmaking process. Focused on the meaning of philanthropy and the importance of getting involved in the community, the program allows students to gain experience in teamwork, assessment of community needs, building consensus, nonprofit finance, and the local nonprofit world.

In partnership with faculty at local school districts, high school students volunteer to form Youth in Philanthropy groups. Throughout the year, each group researches school-based and community needs and strengths, while exercising their leadership and decision-making skills. Contributions from generous community members allow each group to award up to \$5,000 annually in grants for youth programs.

Corresponding with the academic calendar, the program meets twice per year for day-long workshops hosted by the Foundation. In addition, school groups meet monthly to carry out the work of their grant round and other philanthropy projects. To celebrate community impact, the students host a grant presentation ceremony annually in April.



“SINGING IN THE RAIN”

In Summer 2020, the Foundation partnered with local artists to display an art exhibit for the community outside the Foundation office. The mural, titled “Singing in the Rain”, represents the following message:

Singing in the Rain is a call for rebirth of the spirit of hope. Each piece painted in sunrise and sunset colors represents the cycle of life. Whether it is pouring all over your head or the sun is shining so brightly that you cannot see, each girl is marching forward with the same determination. This installation was a love letter to the community. It is a gentle reminder that another day is coming and new chances to try again are on each horizon.

This message of positivity and hope has been embraced by the 2020-21 Youth in Philanthropy students as their program theme. During each meeting, students focus on hope and encouragement. Activities include designing an updated needs assessment to identify current issues facing youth during the COVID-19 pandemic. The results of their study help students align their grantmaking with the most urgent needs. In addition, students create videos to spread the message of the theme and highlight positive aspects they have discovered.
